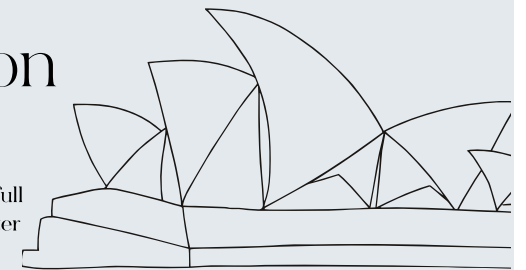
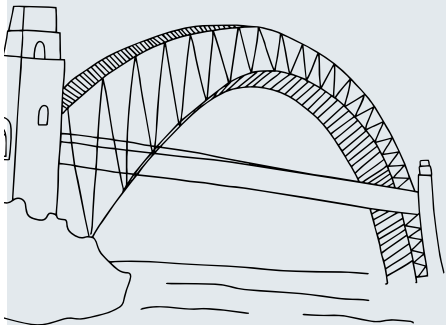

# Terms & Conditions

\*Terms and Conditions for Entry to Harbourfront Seafood Restaurant Sydney on New Year's Eve 2020

\*We kindly request that the Booking representative ensures that all their group attendees are aware of the below conditions

## 1. Age Restrictions & Identification

- a. This is a supervised event, all persons under the age of 18 must be accompanied by a parent or legal guardian
- b. All guests must present valid photo proof of age ID upon entry. This is a driver's licence, passport, or other valid photo identification card. Failure to provide valid photo identification will result in the ticket holder denied entry to the event and/or precinct.
- c. Each guest must present a valid reservation number and name at the time of admission to the event to gain access.

## 2. Entry Conditions

- a. No booking is confirmed unless full prepayment is received
- b. Unauthorised resale or duplication of a reservation will prevent the holder from being admitted to the event. Tickets are not to be used for advertising, promotion or other commercial purposes without the written permission of Harbourfront Seafood Restaurant.
- c. All tickets will be subject to a search of the person and/or bag search for security purposes. Each ticket holder gives consent to such a person. If a ticket holder does not permit that search, he/she will be refused to the venue and event.
- d. If you arrive before the schedule start time, you will be asked to wait in an assembly area until ticket scanning commences

## 3. Event

- a. Harbourfront Seafood Restaurant or authorised staff, acting reasonably, reserve the absolute right to deny admission to any person to the event
- b. Although Harbourfront Seafood Restaurant will endeavour to adhere to the advertised program and package, Harbourfront Seafood Restaurant reserves the right to vary elements of the event program and package at its sole discretion.
- c. There is to be no glass, alcohol, or illegal substances brought onto the Campbell's Stores site and restaurant. Anyone breaching these conditions will be removed from the event.
- d. Harbourfront Seafood Restaurant will not take any responsibility for any loss or damage to your property or for injury to the person or death of you or your invitees at the Event or in the common areas of Campbell's Stores and precinct.
- e. It is a strict no smoking event, outside of the allocated smoking areas in the precinct
- f. Food Allergies - Special dietaries and intolerances will be catered for where notified prior to the event date. To the best of our ability, due care will be taken to ensure that meals and beverages served to guests with food allergies and intolerances are free of the notified guests. However, we cannot guarantee that trace elements will not be contained in the purchased components of these foods and beverages. Please ensure that the event coordinator is notified of the guests suffering food allergy and intolerances at least 7 working days prior to the event.
- g. Conduct - the client is responsible for the orderly behaviour of their guests and Harbourfront Seafood Restaurant reserves the right, without liability for costs, damages or expenses, to intervene or refuse entry to Harbourfront Seafood Restaurant. The client is responsible for any damage caused to Harbourfront Seafood Restaurant by them or their guests.
- h. In the event of an actual or suspected emergency for any type or threat to the security of the Event, Harbourfront Seafood Restaurant or Campbell's Store may give a directive to evacuate the Venue and the site and/or private people entering the venue and the Campbell's Stores site at its sole discretion
- i. All guests in attendance for the event agree to follow the latest guidance and restrictions given by the government of Australia in relation to any pandemic, outbreak or health concerns. Any guests failing to follow guidance or comply with restrictions, will be removed from the event.
- j. No specific seating will be guaranteed and view of the fireworks are not from individual tables

## 4. Cancellation

- a. Harbourfront Seafood Restaurant and Campbell's Stores reserve the right to cancel the event for any reason either before or during the event.
- b. In the event that you are unable to attend the event, a refund will be issued for the full ticket price minus any fees incurred by Harbourfront Seafood Restaurant up to 30 November 2020.
- c. In the event that you are unable to attend the event, a 50% refund will be issued for the full ticket price minus any fees incurred by Harbourfront Seafood Restaurant from 1 December 2020 to 22 December 2020
- d. In the event that you are unable to attend the event from 23 December 2020 all funds will be forfeited
- e. No refund of the ticket (in full or in part) will be offered in any other circumstances including but not limited to inclement weather, cancellation of the fireworks, failure to adhere to the conditions and/or the supplementary conditions, any actual or suspected emergency or threat to security, a change in your personal circumstances, your inability for any reason to attend the event, eviction of you or your invitees from the event, or if you leave the event.
